PUBLIC AGENCY USE

APPLICANT: State of California
Department of Water Resources
P.O. Box 388
Sacramento, California 95802

AREA, TYPE LAND AND LOCATION:
A 0.10+ acre (4486.68 square feet), 6 parcel
aggregate, tide and submerged land, Old
River, Contra Costa County.

LAND USE: Acoustical water velocity meters.

TERMS OF ORIGINAL PERMIT:
Initial period: 10 years from April 1,
1969.

Consideration: Public Benefit.

TERMS OF PROPOSED REPLACEMENT PERMIT:
Initial period: 10 years from April 1,
1979.

CONSIDERATION: The public use and benefit with the State
reserving the right at any time to set
a monetary rental if the Commission finds
such action to be in the State's best interest.

BASIS FOR CONSIDERATION:
Title 2, Div. 3 of Cal. Adm. Code.

1. This is a Replacement Permit for Permit

water meter devices.

CALENDAR ITEM NO. C7. (C NTD)

2. The water measuring equipment at the subject location consists of meters on pilings and connected armored submersible cables used to transmit readings. The cable is buried at least 5 feet below the channel bottom.
3. The annual rental value of the site is estimated to be \$100.
4. An EIR is not required. This transaction is within the purview of 2 Cal. Adm. Code 2907, Class 1(B), which exempts an existing structure or facility that is in an acceptable state of repair and there is no evidence of record to show injury to adjacent property, shoreline erosion, or other types of environmental degradation.
5. This project is situated on State land identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and is classified in a use category, Class B, which authorizes Limited Use.


IT IS RECOMMENDED THAT THE COMMISSION:




