MODIFICATION OF DREDGING PERMIT PRC 5009.9

PERMITTEE: City of Vallejo  
555 Santa Clara Street  
Vallejo, California 94590

RESUME OF PREVIOUS ACTION:

Permit PRC 5009.9 was issued to the City of Vallejo on April 30, 1975, effective through December 31, 1980, to provide for dredging 350,000 cubic yards initially and 25,000 cubic yards annually from an area of State tide and submerged lands in Mare Island Strait as a part of the Vallejo Waterfront Redevelopment Project. Dredging of an additional 300,000 cubic yards was authorized on September 30, 1976. The Commission determined that an EIR for the project had been prepared and certified by the City of Vallejo on January 22, 1975.

PROPOSED MODIFICATION:

On October 9, 1979, the City of Vallejo requested authorization to complete the remainder of the Redevelopment Project over a five year period commencing January 1, 1980, by dredging an additional 350,000 cubic yards and 25,000 cubic yards annually from sovereign granted tide and submerged lands adjacent to the area previously dredged. The dredging will provide access to and mooring spaces for, a proposed marine construction operations center. Environmental effects of the proposed project were addressed in the EIR reviewed and considered by the Commission on April 30, 1975. A supplement to the project EIR was certified by the Vallejo Redevelopment Agency on October 1, 1979. It was determined that certain fill aspects of the project would have a significant effect on the environment which would be mitigated by conversion of a larger dry land parcel to wetland.



IT IS RECOMMENDED THAT THE COMMISSION:

1. DETERMINE THAT AN EIR SUPPLEMENT HAS BEEN PREPARED FOR THIS PROJECT AND CERTIFIED BY THE VALLEJO REDEVELOPMENT AGENCY ON OCTOBER 1, 1979.
2. CERTIFY THAT THE INFORMATION CONTAINED IN THE EIR SUPPLEMENT HAS COMPLIED WITH CEQA, AS AMENDED, AND THE STATE EIR GUIDELINES, AND HAS BEEN REVIEWED AND CONSIDERED BY THE COMMISSION.
3. DETERMINE THAT THE PROJECT WILL HAVE A SIGNIFICANT EFFECT ON THE ENVIRONMENT WHICH WILL BE MITIGATED BY CONVERSION OF A DRY LAND PARCEL TO WETLAND.
4. AUTHORIZE AMENDMENT OF PERMIT PRC 5009.9 TO THE CITY OF VALLEJO PROVIDING FOR A 5 YEAR AUTHORIZATION FROM JANUARY 1, 1980, IN CONSIDERATION OF THE PUBLIC USE AND BENEFIT, TO DREDGE 350,000 CUBIC YARDS INITIALLY AND 25,000 CUBIC YARDS ANNUALLY FROM THE MARE ISLAND STRAIT, SOLANO COUNTY, AS DESCRIBED IN EXHIBIT A AND TO DEPOSIT SUCH MATERIALS AT DISPOSAL SITE SF-9, CARQUINEZ STRAIT: SUCH PERMISSION BEING IN ADDITION TO PREVIOUS AUTHORIZATIONS UNDER PERMIT PRC 5009.9.

OF THE REDEVELOPMENT AGENCY  
OF THE CITY OF VALLEJO

The Members of the Redevelopment Agency of the City of Vallejo met in regular session in the City Council Chambers, City Hall, 555 Santa Clara Street, Vallejo, California, at 9:28 p.m. Monday, October 1, 1979.

Chairman Curtola called the meeting to order, and upon roll call those present and absent were as follows:

Motion was duly made and seconded that the following resolution be adopted:

RESOLUTION NO. 79-42

RESOLUTION CERTIFYING FINAL SUPPLEMENT TO  
PROJECT EIR FOR VALLEJO WATERFRONT REDEVELOPMENT PROJECT

BE IT RESOLVED by the Redevelopment Agency of the City of Vallejo as follows:

THAT WHEREAS, the Redevelopment Agency of the City of Vallejo did on May 28, 1974, certify the Final Project EIR for Vallejo Waterfront Redevelopment Project; and

WHEREAS, San Francisco Bay Conservation and Development Commission (BCDC) has required further environmental assessment of certain activities proposed at said project before it will process Vallejo's application for permission to proceed with said activities; and

WHEREAS, the Agency in response to direction from BCDC did employ Woodward-Clyde Consultants to prepare a supplement to the Project EIR to evaluate said activities; and

WHEREAS, Woodward-Clyde Consultants has prepared a Draft Supplement pursuant to provisions of the California Environmental Quality Act of 1970, as amended (CEQA), and State Guidelines for implementation of said act, and has circulated said Draft Supplement through the State Clearinghouse for comments; and

WHEREAS, Woodward-Clyde Consultants has evaluated comments received through the State Clearinghouse and through local distribution and has prepared a Final Supplement to the Project EIR for the Vallejo Waterfront Redevelopment Project; and

WHEREAS, Agency has reviewed and evaluated both Draft and Final Supplements to the Project EIR; now, therefore,
