GENERAL PERMIT
RECREATIONAL USE

APPLICANT: San Joaquin Delta Power Squadron
3216 Telegraph Avenue
Stockton, California 95204

AREA, TYPE LAND AND LOCATION: Three circular parcels totaling .005 acres
of tide and submerged land in the San Joaquin
River, San Joaquin County.

LAND USE: Maintenance of three speed zone signs.

TERMS OF PROPOSED PERMIT:
Initial period: 10 years from December 1,
1979.

Public liability insurance: Combined single
limit coverage of \$100,000.

CONSIDERATION: \$30 per annum, with the State reserving
the right to fix a different rental on
each fifth anniversary of the permit and
the public safety.

BASIS FOR CONSIDERATION:
\$30 fixed rental for this type of permit.

PREREQUISITE TERMS, FEES AND EXPENSES:
Filing fee and \$30 for the first year's
rental have been received.

The speed signs are located on the San
Joaquin River for which no upland owner
permission is necessary.

OTHER PERTINENT INFORMATION:

1. Existing dock facilities are currently under lease pursuant to PRC 5212.1, approved December 15, 1976, Minute Item No. 8.
2. This project is exempt from CEQA because it involves the addition of safety devices for use in conjunction with an existing facility.

Authority: Title 14, Cal. Adm. Code 15101
Class (if)

3. This project is situated on State land identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and is classified in a use category, Class B, which authorizes Limited Use.

Staff has coordinated this project with those agencies and organizations which nominated the site as containing significant environmental values. They have found this project to be compatible with their nomination.

IT IS RECOMMENDED THAT THE COMMISSION:


1. DETERMINE THAT AN EIR HAS NOT BEEN PREPARED FOR THIS ACTIVITY AS SUCH REPORT IS NOT REQUIRED UNDER THE PROVISIONS OF P.R.C. 21085, 14 CAL. ADM. CODE 15100 ET SEQ., AND 2 CAL. ADM. CODE 2907.
2. FIND THAT GRANTING OF THE PERMIT WILL HAVE NO SIGNIFICANT EFFECT UPON ENVIRONMENTAL CHARACTERISTICS IDENTIFIED PURSUANT TO SECTION 6370.1, OF THE P.R.C.
3. AUTHORIZE ISSUANCE TO SAN JOAQUIN DELTA POWER SQUADRON OF A 10-YEAR GENERAL PERMIT - RECREATIONAL USE FROM DECEMBER 1, 1979; IN CONSIDERATION OF ANNUAL RENT IN THE AMOUNT OF \$30 AND THE PUBLIC SAFETY, WITH THE STATE RESERVING THE RIGHT TO FIX A DIFFERENT RENTAL ON EACH FIFTH ANNIVERSARY OF THE PERMIT; PROVISION OF PUBLIC LIABILITY INSURANCE FOR COMBINED SINGLE LIMIT COVERAGE OF \$100,000; FOR THE CONSTRUCTION AND MAINTENANCE OF THREE SPEED LIMIT SIGNS ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.


