EXTENSION OF DREDGING PERMIT  
(MAINTENANCE)

APPLICANT: City of Morro Bay  
Public Works Department  
695 Harbor Street  
Morro Bay, California 93442

AREA, TYPE LAND AND LOCATION:  
State-owned granted (minerals reserved)  
tide and submerged lands in Morro Bay Harbor,  
Morro Bay, San Luis Obispo County.

RESUME OF PREVIOUS ACTION:

The Commission on March 30, 1978, authorized issuance of Dredging Permit PRC 5463.9 to the City of Morro Bay effective through December 31, 1978, for maintenance dredging of 70,000 cubic yards of material from designated mooring areas in Morro Bay Harbor. The work was to be included with a Corps of Engineers project which the Corps was unable to perform in 1978. The applicant then requested extension of the permit through 1979, which request was approved by the Commission on August 31, 1978. The Corps has now awarded a contract for the work, to be performed during 1980. The project was determined to be categorically exempt from the requirements of CEQA pursuant to Section 15104 of the CEQA Guidelines.

PROPOSED MODIFICATION:

1. Extend the effective date of Dredging Permit PRC 5463.9 from January 1, 1980 through December 31, 1980.
2. All other conditions of Dredging Permit PRC 5463.9 are to remain in full effect.

CONSIDERATION: Public use and benefit.

IT IS RECOMMENDED THAT THE COMMISSION:

1. DETERMINE THAT AN EIR HAS NOT BEEN PREPARED FOR THIS PROJECT AS SUCH REPORT IS NOT REQUIRED UNDER PROVISIONS OF P.R.C. 21085, 14 CAL. ADM. CODE 15100 ET SEQ. AND 2 CAL. ADM. CODE 2907, CLASS 4 WHICH CATEGORICALLY EXEMPTS MAINTENANCE DREDGING OPERATIONS.
2. DETERMINE THAT THE PROJECT IS CONSISTENT WITH THE PROVISIONS OF ARTICLE 6.5 OF TITLE 2 OF THE CALIFORNIA ADMINISTRATIVE CODE.
3. AUTHORIZE THE EXTENSION OF DREDGING PERMIT PRC 5463.9 TO THE CITY OF MORRO BAY FROM JANUARY 1, 1980 THROUGH DECEMBER 31, 1980; SUCH PERMISSION BEING CONTINGENT UPON APPLICANTS COMPLIANCE WITH ALL APPLICABLE PERMITS, RECOMMENDATIONS OF LIMITATIONS ISSUED BY FEDERAL, STATE AND LOCAL GOVERNMENTAL AGENCIES.
