SAN JOAQUIN COUNTY

ON JULY 21, 1980, STAFF WAS CONTACTED BY THE SAN JOAQUIN COUNTY SHERIFF'S DEPARTMENT CONCERNING A SAFETY PROBLEM AT THE INTERSECTION OF PARADISE CUT, SUGAR CUT AND SALMON SLOUGH IN SOUTHERN SAN JOAQUIN COUNTY. A SAND BAR HAS DEVELOPED NEAR THIS INTERSECTION FORCING BOATERS TO USE ONLY A SMALL PORTION OF THE WATERWAY. ONE FATAL ACCIDENT HAS ALREADY OCCURRED IN THIS AREA AND SEVERAL NEAR MISSES OCCUR DAILY. THE SHERIFF'S DEPARTMENT HAS REQUESTED THE COMMISSION'S PERMISSION TO INSTALL APPROPRIATE WARNING SIGNS EITHER IN THE WATERWAY OR ON ADJOINING LAND SITES.

BECAUSE OF THE IMMEDIATE NEED TO ALLEVIATE THIS HAZARDOUS SITUATION, I HAVE SENT A LETTER TO THE SAN JOAQUIN COUNTY SHERIFF'S DEPARTMENT ADVISING THEM THAT THE COMMISSION HAS NO OBJECTION TO THEIR INSTALLATION OF APPROPRIATE WARNING SIGNS ON LANDS UNDER ITS JURISDICTION. THE COUNTY WILL MAKE FORMAL APPLICATION FOR A PERMIT FROM THE COMMISSION.
