GENERAL PERMIT - PUBLIC AGENCY USE

APPLICANT: Marin County Park and Recreation Department
Civic Center
San Rafael, California 94903

AREA, TYPE LAND AND LOCATION:
10.88 acre parcel of submerged land in
Upper Richardson Bay, Marin County.

LAND USE: Multi-purpose path for bicycles, jogging,
walking, etc.

TERMS OF PROPOSED PERMIT:
Initial period: 49 years from January 1,
1981.

CONSIDERATION: The public use and benefit, with the State
reserving the right at any time to set
a monetary rental if the Commission finds
such action to be in the State's best interest.

BASIS FOR CONSIDERATION:
Pursuant to 2 Cal. Adm. Code 2005.

PREREQUISITE TERMS, FEES AND EXPENSES:
Applicant is owner of upland.
Filing fee has been received.

STATUTORY AND OTHER REFERENCES:
A. P.R.C.: Div. 6, Parts 1 & 2; Div. 13.
B. Cal. Adm. Code: Title 2, Div. 3; Title 14,
Div. 6.

OTHER PERTINENT INFORMATION:
1. Marin County proposes to construct
two support trestles, reconstruct two
existing trestles; and construct a
10-foot wide, 7,200-foot long, multi-purpose
public access pathway.
2. Because of the uncertainty of the
extent of the State's title in this
area, it is recommended that expense
and processing fees be waived.

3. The annual rental value of the site is estimated to be \$1300.
4. A Negative Declaration was prepared by Marin County, Division of Environmental Services, pursuant to CEQA and the State EIR Guidelines.
5. This project is situated on land identified as possessing environmental values in that the State Lands Commission stated all waterways under the Commission's jurisdiction have environmental significance. Staff finds this project to be compatible with Commission policy.

1. DETERMINE THAT A NEGATIVE DECLARATION HAS BEEN PREPARED FOR THIS PROJECT BY MARIN COUNTY, DIVISION OF ENVIRONMENTAL SERVICES.
2. CERTIFY THAT THE COMMISSION HAS REVIEWED AND CONSIDERED THE INFORMATION CONTAINED IN THE NEGATIVE DECLARATION.
3. DETERMINE THAT THE PROJECT WILL NOT HAVE A SIGNIFICANT EFFECT ON THE ENVIRONMENT.
4. FIND THAT THIS PROJECT IS SITUATED ON LAND IDENTIFIED AS POSSESSING ENVIRONMENTAL VALUES IN THAT THE STATE LANDS COMMISSION FOUND ALL WATERWAYS UNDER THE COMMISSION'S JURISDICTION HAVE ENVIRONMENTAL SIGNIFICANCE, BUT THAT THIS PROJECT IS COMPATIBLE WITH THAT FINDING AS IT APPLIES TO THE SUBJECT LAND.
5. AUTHORIZE ISSUANCE TO MARIN COUNTY PARK AND RECREATION DEPARTMENT OF A 49-YEAR GENERAL PERMIT - PUBLIC AGENCY USE FROM JANUARY 1, 1981; IN CONSIDERATION OF THE PUBLIC USE AND BENEFIT, WITH THE STATE RESERVING THE RIGHT

AT ANY TIME TO SET A MONETARY RENTAL IF THE COMMISSION FINDS SUCH ACTION TO BE IN THE STATE'S BEST INTEREST; FOR A MULTI-PURPOSE PATH FOR BICYCLES, JOGGING, WALKING, ETC. ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

6. WAIVE EXPENSE AND PROCESSING FEES FOR THIS TRANSACTION.

EXHIBIT "A"

LAND DESCRIPTION

W 22540

A 60-foot-wide strip of tide and submerged land in upper Richardson Bay, Marin County, California, said strip lying 30 feet on each side of the following described center line:

BEGINNING at the point of intersection of the boundary line being the northerly line of Lot C and the center line of the Northwestern Pacific Railroad Company, said point of intersection is described in that certain grant deed recorded 7/17/1980 in Book 3733, Page 596 (Sheet 2 of 4); thence along the center line of said railroad S 06°00'W 140 feet, more or less, to a curve to the left having a radius of 1243.57 feet, a distance of 347 feet; thence S 07°05'E 5000 feet, more or less, to a curve to the left having a radius of 1273.57 feet, a distance of 864.40 feet; thence S 46°26'E 1550 feet, and the end of the herein-described center line, said center line terminates at the northwesterly boundary of Coyote Canal, shown on Map No. 1 of salt marsh and tidelands.

EXCEPTING THEREFROM any portion lying landward of the mean high tide line of upper Richardson Bay.

NEGATIVE DECLARATION

Marin County
Division of Environmental Services

Pursuant to: Section 21000 et seq of the Public Resources Code and Marin County Environmental Impact Review Guidelines and Procedures, a Negative Declaration is hereby granted for the following project.

1. Project Name: NORTHWESTERN PACIFIC RAILROAD RIGHT-OF-WAY FEDERAL FUNDING

2. Location and Description: Acquisition & development of the abandoned NWPRR right-of-way between the south bank of Coyote Creek and the Scott Valley tunnel in Mill Valley. Will provide public access to recreation and conservation areas.
