CLOSING ACCOUNTS OF EXPENDITURES

SUBSIDENCE REMEDIAL WORK:

Subsidence Maintenance and Repairs, July 1,  
1979 to June 30, 1980.

Subsidence Studies, July 1, 1979 to June 30,  
1980.

FISCAL IMPACT: Total subsidence costs for these accounts  
amount to \$239,237.92. Expenditures in  
the total amount of \$239,760.36 were previously  
reported for these accounts for the purposes  
of withholding tideland oil revenue due  
the State. Therefore, there will be a credit  
of \$522.24 to the State.

COMMISSION APPROVAL:

June 27, 1979, Minute Item 27.

CONDITIONS FULFILLED:

1. That the amounts, if any, to be allowed ultimately as subsidence costs, deductible under Section 4(d) of Chapter 138/64, 1st E.S., would be determined by the Commission upon an engineering review and final audit subsequent to the time when the work is completed. The work is now completed.
2. That the scope of work conform in essential details to the definitions of such items as defined by the Commission. This has been done.
