GENERAL PERMIT - RIGHT-OF-WAY USE

APPLICANT: Pacific Telephone and Telegraph Company
1260 Fulton Avenue
Sacramento, California 95825

AREA, TYPE LAND AND LOCATION:
A 0.04-acre parcel of tide and submerged
land in Pudding Creek at State Highway 1
near Fort Bragg, Mendocino County.

LAND USE: Construction and maintenance of a buried
submarine telephone duct and cable crossing.

TERMS OF PROPOSED PERMIT:
Special: Continuous use plus one
year from June 1, 1981.

CONSIDERATION: Exempt by law, Section 7901, Public Utilities
Code.

PREREQUISITE TERMS, FEES AND EXPENSES:
Applicant is permittee of upland.

Filing fee and processing costs have been
received.

2. An EIR is not required. This transaction is within the purview of 14 Cal. Adm. Code, Div. 6, Section 15103, which exempts construction and installation of small new equipment and facilities.
3. This project is situated on land identified as possessing environmental values in that the State Lands Commission stated all waterways under the Commission's jurisdiction have environmental significance. Staff finds this project to be compatible with Commission policy.
4. Staff has coordinated this project with interested agencies and organizations. They have found this project to be without objection as long as any damaged areas are restored.
5. This project is consistent with the provisions of Article 6.5 because it is located in close proximity to an existing developed area. 2 Cal. Adm. Code, Section 2532.


IT IS RECOMMENDED THAT THE COMMISSION:

1. DETERMINE THAT AN ENVIRONMENTAL DOCUMENT HAS NOT BEEN PREPARED FOR THIS ACTIVITY AS SUCH DOCUMENT IS NOT REQUIRED UNDER THE PROVISIONS OF P.R.C. 21084, 14 CAL. ADM. CODE 15100 ET SEQ.
2. DETERMINE THAT THE PROJECT IS CONSISTENT WITH THE PROVISIONS OF ARTICLE 6.5, OF TITLE 2, OF THE CAL. ADM. CODE.

3. FIND THAT THIS PROJECT IS SITUATED ON LAND IDENTIFIED AS POSSESSING ENVIRONMENTAL VALUES IN THAT THE STATE LANDS COMMISSION FOUND ALL WATERWAYS UNDER THE COMMISSION'S JURISDICTION HAVE ENVIRONMENTAL SIGNIFICANCE, BUT THAT THIS PROJECT IS COMPATIBLE WITH THAT FINDING AS IT APPLIES TO THE SUBJECT LAND.

4. AUTHORIZE ISSUANCE TO THE PACIFIC TELEPHONE AND TELEGRAPH COMPANY FOR CONTINUOUS USE, PLUS ONE YEAR, A GENERAL PERMIT - RIGHT-OF-WAY USE FROM JUNE 1, 1981 WHICH IS EXEMPT FROM CONSIDERATION UNDER SECTION 7901, PUBLIC UTILITIES CODE, FOR THE CONSTRUCTION AND MAINTENANCE OF A BURIED SUBMARINE TELEPHONE DUCT AND CABLE CROSSING ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.


