CORE DRILLING PERMIT

APPLICANT:

Great Western Cities, Inc.  
4605 Lankersheim Blvd., Suite 600  
North Hollywood, California 91602

PERMIT LANDS:

16,000 acres in 26 parcels of patented school and lieu lands with minerals reserved to the State, located in T30S and T31S, R39E; T31S and T32S, R40E, MDB&M, California City, Kern County, as described in Exhibit "A" and shown in Exhibit "B", both attached hereto.

PROPOSED PROJECT:

A maximum of 30 completed holes to a maximum depth of 750 feet will be drilled to obtain geologic information concerning the parcels of State-interest lands. The actual number of holes will be determined according to data obtained as the coring progresses. The core drilling program and study will be conducted by a drilling contractor and registered geologist retained by Great Western Cities, Inc., with the Commission's staff exercising control over the program. Existing roads will be used where possible. The geologic information gathered will be evaluated to allow for long-range development planning by Great Western Cities, Inc. If the geologic study indicates the absence of commercially valuable ore bodies in any of the State-interest parcels, Great Western Cities, Inc., will consider applying for a modification of the State's right of surface entry to those parcels under PRC 6401(b). This project will provide data required for the Commission to determine whether or not to release or modify the State's right of entry. The number, location, coring depth and procedures for the drilling program will be under supervision of the SLC staff.

CALENDAR ITEM NO. 21 (CONTD)

TERMS: The drilling term shall be one year. The term will commence after Commission action and filing of the Notice of Exemption.

CONSIDERATION: The public benefit in obtaining geologic data and a report prepared by a registered geologist. All geologic information from this core drilling program will be made public information.

PREREQUISITE ITEMS:

1. Statutory filing fee and expense deposit have been submitted by the applicant.
2. The applicant has furnished the required performance bond in the amount of \$10,000.
3. The application and coring permit have been reviewed, and the permit approved as to form, by the Office of the Attorney General for compliance with statutory requirements and conformance with regulations of the State Lands Commission.
4. The applicant will reimburse the State for all staff expenses incurred in supervising the drilling program and has made an initial deposit of \$3,000.

OTHER PERTINENT INFORMATION:

1. This permit is exempt from CEQA pursuant to Title 2, Cal. Adm. Code Section 2907, Class 6(B), core-hole drilling program conducted for the purpose of mineral evaluation pursuant to PRC 6401(b) where minimal or no disturbance of the land surface results.
2. This project is situated on school and lieu lands not identified as possessing significant environmental values. A staff review of available environmental information indicates no reason to identify the subject land parcels as having such values at this time.

2. AUTHORIZE THE ISSUANCE TO GREAT WESTERN CITIES, INC., OF A CORE-DRILLING PERMIT FOR THE PERIOD JUNE 24, 1981 THROUGH JUNE 23, 1982, ON PATENTED SCHOOL AND LIEU LANDS ON WHICH THE STATE HAS RESERVED THE MINERALS, LYING WITHIN THE LIMITS OF CALIFORNIA CITY, KERN COUNTY, SAID LANDS BEING DESCRIBED IN EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF AS PART OF A GEOLOGICAL DATA GATHERING PROCEDURE AND STUDY.


