Area Amendment: An addition of Section 36, T18½N, R12E, SBM, containing ~~633.75±~~ acres is incorporated into the lease by this amendment for a total of 6,250.51± acres in the grazing lease.

Appraised value for proposed use.

PREREQUISITE TERMS, FEE AND EXPENSES:

Rental for the period of January 1, 1981 through September 20, 1981 has been received.

OTHER PERTINENT INFORMATION:

1. This project is exempt from CEQA under 2 Cal. Adm. Code, Article 10, Section 2907, Class 4(A), "Grazing of livestock where disturbance of soil does not occur."
2. A portion of this project is situated on State land identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and is classified in a use category, Class A and B, which authorizes Restricted and Limited Use. Section 36, T18½N, R12E, SBM, is not identified as possessing significant environmental values.
3. Staff has coordinated this project with those agencies and organizations which nominated the site as containing significant environmental values. They have found this project to be compatible with their nomination.


