SUBSIDENCE REMEDIAL WORK:

Subsidence Maintenance and Repairs, July 1,  
1980 to June 30, 1981.

Subsidence Studies, July 1, 1980 to June 30,  
1981.

FISCAL IMPACT: Total subsidence costs for these accounts  
amount to \$173,814.55. Expenditures of  
this amount were previously reported for  
these accounts in withholding tideland  
oil revenues due the State.

COMMISSION APPROVAL:

June 26, 1980, Minute Item 36.

CONDITIONS FULFILLED:

1. That the amounts, if any, to be allowed  
ultimately as subsidence costs, deducti-  
ble under Section 4(d) of Chapter  
138/64, 1st E.S., would be determined  
by the Commission upon an engineering  
review and final audit subsequent to  
the time when the work is completed.  
The revue and audit have been accomplished.
2. That the scope of work conform in es-  
sential details to the definitions  
of such items as defined by the Com-  
mission. This has been done.
