REVISION IN LEASE RENTAL
AFTER ROUTINE REVIEW

LESSEE: Raymond Castanchoa and
Alfred Saldubehere
Route 1, Box 106
McFarland, California 93250

This is a Grazing Lease for a term of ten years from July 27, 1977 through July 26, 1987, with an existing annual rent of \$28.27; the lease consists of three parcels of State school land containing 767.2[±] acres in San Bernardino County for livestock grazing use.

This project is exempt from CEQA because it is not a project as defined within the State EIR Guidelines.

Authority: 2 Cal. Adm. Code 2903(d).

The lease provides that the State may adjust the annual rental at a different amount for the five-year term following the fifth anniversary of the lease, effective on such anniversary date. The lessee was notified of the adjusted rental within the time constraints set by this lease.


