TERMINATION AND QUITCLAIM OF LEASE PRC 5505.1

AREA, TYPE LAND AND LOCATION:  
13 parcels of submerged land in the Pacific  
Ocean near Carlsbad, San Diego County.

LAND USE: Maintenance of 13 environmental monitoring  
buoys.

TERMS OF ORIGINAL LEASE:  
Initial period: Three years from August 1,  
1978.

Consideration: \$550 per annum.


