GENERAL PERMIT - RECREATIONAL USE

APPLICANT: Benjamin J. and Marjorie J. Verduco
6420 Miles Lane
Carmichael, California 95608

AREA, TYPE LAND AND LOCATION:
A 0.03-acre parcel of submerged land, in
the Sacramento River, at Colusa, Colusa
County.

LAND USE: Maintenance of a recreational dock and
walkway.

TERMS OF ORIGINAL PERMIT:

Initial period: Three years from June 1,
1979.

Public Liability Insurance: Combined single
limit coverage of \$100,000.

Consideration: \$40 per annum.

TERMS OF PROPOSED PERMIT:

Initial period: Five years from June 1,
1982.

Public liability insurance: Combined single
limit coverage of \$100,000.

CONSIDERATION: \$50 per annum.

BASIS FOR CONSIDERATION:

Pursuant to 2 Cal. Adm. Code 2003.

PREREQUISITE TERMS, FEES AND EXPENSES:

Applicant is permittee of upland.

2. AUTHORIZE ISSUANCE TO BENJAMIN J. AND MARJORIE J. VERDUSCO OF A FIVE-YEAR GENERAL PERMIT - RECREATIONAL USE FROM JUNE 1, 1982; IN CONSIDERATION OF ANNUAL RENT IN THE AMOUNT OF \$50; PROVISION OF PUBLIC LIABILITY INSURANCE FOR COMBINED SINGLE LIMIT COVERAGE OF \$100,000; FOR MAINTENANCE AND USE OF A RECREATIONAL DOCK AND WALKWAY ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

EXHIBIT "A"

LAND DESCRIPTION

WP 5723

A parcel of submerged land in the State-owned bed of the Sacramento River at the city of Colusa, Colusa County, California, more particularly described as follows:

All that land lying immediately beneath and extending 10 feet from all sides of an existing floating dock, said dock being adjacent to the right bank of the Sacramento River and lying northerly of Block 3 as shown on the map of the city of Colusa, filed in Book 1 of Maps, at page 45, Colusa County records.

EXCEPTING THEREFROM any portion lying landward of the ordinary low water mark of the Sacramento River.


