APPLICATION FOR A GEOTHERMAL
EXPLORATORY PERMIT

APPLICANT: GRI Operator Corporation
2300 County Center Drive, Suite 264
Santa Rosa, California 95401

AREA, TYPE LAND AND LOCATION:
686 acres of reserved mineral land near
the Geysers, Lake and Mendocino Counties.

LAND USE: Drill three temperature gradient holes
to a depth of 2,000 feet. The purpose of
the testing will be to evaluate the geothermal
potential of State lands as well as adjacent
federal and private lands. These lands
will be offered for lease by competitive
public bid on June 29, 1982.

TERMS OF PROPOSED PERMIT:
Six months.

PREREQUISITE FEES:
The required processing fee has been deposited
by the applicant.

STATUTORY AND OTHER REFERENCES:

OTHER PERTINENT INFORMATION:
1. This project is exempt from CEQA because
it is within the purview of 2 Cal.
Adm. Code 2905, Class 6, which exempts
the collection of data for information
purposes where minimal or no disturbance
of State land is involved.
2. This project is situated on reserved
mineral lands not identified as possessing

1. FIND THAT AN ENVIRONMENTAL DOCUMENT IS NOT REQUIRED FOR THIS PROJECT AS IT HAS BEEN EXEMPTED FROM THE REQUIREMENTS OF CEQA AS A CATEGORIZED EXEMPTION, CLASS 6 (P.R.C. 21084; CAC 15100, ET. SEQ.)
2. AUTHORIZE ISSUANCE ON A NON-EXCLUSIVE GEOTHERMAL EXPLORATION PERMIT FOR SIX MONTHS TO GRI OPERATOR CORPORATION TO DRILL TEMPERATURE GRADIENT HOLES ON RESERVED MINERAL LANDS DESCRIBED IN EXHIBIT "A". SAID PERMIT SHALL USE THE FORM CURRENTLY ON FILE IN THE OFFICE OF THE COMMISSION.


