DREDGING PERMIT

In accordance with the Commission's delegation of authority to the Executive Officer for the issuance of dredging permits of 10,000 cubic yards or less, Minute Item 32, February 24, 1977, permission was granted to perform maintenance dredging on State-owned lands to the following party:

APPLICANT: Waldo Giacomini  
P. O. Box 126  
Point Reyes Station, California 94956

The permit provides for dredging 6,000 cubic yards of sediments from tide and submerged lands in the bed of Lagunitas Creek, Marin County. Dredging is required to repair 2,300 feet of levee damaged by winter storms. Material will be dredged from Lagunitas Creek and placed on the adjacent levee. No royalty will be charged for material used to repair the levee as shown on map as area "B". A royalty of \$0.25 per cubic yard will be charged for spoils placed on private uplands other than the levee or sold for commercial benefit. The permit is effective September 1, 1982 through December 31, 1982.

In compliance with said delegation of authority, it has been determined that the following conditions have been met:

1. The proposed project is categorically exempt from the requirements of CEQA, pursuant to the provisions of Section 15104 of the CEQA Guidelines.
2. Issuance of the permit and the resultant project will have no significant adverse effect on the environment or the environmental characteristics identified pursuant to Section 6370.1 et. seq., of the P.R.C.

CALENDAR ITEM NO. 31 (CONTD)

3. The dredging amount will not exceed 10,000 yards.
4. A charge per cubic yard will be assessed for spoil material that is deposited on private property elsewhere or sold commercially.
5. Approval of the project will be contingent upon approval by all pertinent State, federal and local agencies.





