APPROVAL OF EXTENSION OF PERMIT
TO PROSPECT FOR MINERALS
OTHER THAN OIL AND GAS
AND GEOTHERMAL RESOURCES,
SAN BERNARDINO COUNTY

PERMITTEE: Duval Corporation
4715 E. Fort Lowell Road
Tucson, Arizona 85712

AREA, TYPE LAND AND LOCATION:
Approximately 269 acres of patented State
school land comprising the SE $\frac{1}{4}$ NW $\frac{1}{4}$, S $\frac{1}{2}$
NE $\frac{1}{4}$ and SW $\frac{1}{4}$ Section 36, T8N, R5E, SBB&M,
San Bernardino County. Parcel is south
of Highway 40 between the towns of Newberry
Springs and Ludlow, approximately 38 miles
east of Barstow and 42 miles west of Amboy.
The State retained 100 percent of the minerals.

MINERALS: Primarily borate minerals, as well as all
other minerals other than oil, gas and
geothermal resources.

TERMS OF EXTENSION:
November 1, 1982 to October 31, 1983.

PREREQUISITE ITEMS:
Application submitted by applicant.
Statutory fees have been submitted by applicant.

OTHER PERTINENT INFORMATION:

1. Prospecting Permit PRC 5906.2 was approved by the Commission on September 24, 1980, effective November 1, 1980. The permit granted the permittee an exclusive right for a period of two years to prospect for minerals other than oil and gas and geothermal resources.
2. Duval has drilled three exploratory drill holes on the State parcel and has found minor and thin borate mineralization. Drilling on adjacent private and federal lands has revealed the existence of a fairly substantial borate orebody which may be amenable to solution mining. Duval plans to conduct pilot testing on the private and federal lands to study the feasibility of solution mining and recovery of borates. If the studies indicate that this method is economically feasible, the borates present on the state parcel may become producible at a profit through unitization of the orebody. Duval has requested a one-year extension of the prospecting permit during which time the pilot operations may be conducted. No new drilling will take place on the state parcel.
3. This project is situated on state land which has not been classified as possessing environmental values.
4. Section 6891 of the P.R.C. provides that the Commission may, in its discretion, extend the term of any prospecting permit for a period not to exceed one year.

ENVIRONMENTAL IMPACT:

Pursuant to Section 21C00 of the P.R.C., a Negative Declaration EIR ND No. 269 was prepared for the prospecting permit. The Negative Declaration was circulated and certified by the Commission on September 24,

1980, as being in compliance with CEQA. Certification included the determination that the proposed project would not have a significant effect on the environment.





