ON NOVEMBER 24, 1982, I EXECUTED A TEMPORARY RIGHT-
OF-ENTRY LETTER AUTHORIZING WOODBRIDGE IRRIGATION DISTRICT
TO ENTER UPON SUBMERGED LANDS IN THE MOKELUMNE RIVER AT LODI,
SAN JOAQUIN COUNTY, FOR A PERIOD OF NINETY (90) DAYS TO CONSTRUCT
TWO TEMPORARY COFFERDAMS FOR REPAIR OF THE DISTRICT'S EXISTING
FLASHBOARD DIVERSION DAM. THE PROJECT IS BEING PERFORMED PURSUANT
TO THE DIRECTION OF THE CALIFORNIA DEPARTMENT OF WATER RESOURCES,
DIVISION OF SAFETY OF DAMS.

AS THE DIVERSION DAM ALSO INCORPORATES A FISH LADDER,
THE CALIFORNIA DEPARTMENT OF FISH AND GAME IS REQUIRING THAT
THE PROJECT BE CARRIED OUT IN A MANNER WHICH WILL NOT INTERFERE
WITH THE SEASONAL MIGRATION OF SALMON. THEREFORE, EACH HALF
OF THE RIVER UPSTREAM FROM THE DIVERSION DAM WILL ALTERNATELY
BE DEWATERED BY A COFFERDAM TO SAFEGUARD THE SALMON ACTIVITY.
UPON COMPLETION OF THE PROJECT, THE COFFERDAMS WILL BE TOTALLY

THE TIME FRAME FOR THIS PROJECT IS CRITICAL BECAUSE OF THE SALMON ACTIVITY AND THE NECESSITY TO COMPLETE THE PROJECT DURING THE PERIOD OF THE RIVER'S SEASONAL LOW LEVEL.

THE DISTRICT REQUESTED THE STATE LANDS COMMISSION'S PERMISSION TO ENTER ONTO THE SUBJECT LANDS BY NOVEMBER 24, 1982, IN ORDER TO COMPLETE THE PROJECT AS REQUIRED.

THIS ACTION IS CATEGORICALLY EXEMPT FROM CEQA AS IT IS A MINOR ALTERATION TO LAND.

On November 17, 1982 Phillips Petroleum Company was before the Coastal Commission requesting to drill up to four exploratory wells on State Lease 2933.1.

I was told by Naomi Schwartz at noon before the hearing that she had been contacted by residents of Arroyo Quemada Lane who were concerned about the drilling which would be within a half or three-quarters of a mile from their homes. Copies of their testimony are attached. The residents said they had just heard of the project. They were asking the Commission to deny the drilling.

Lindsay Patterson, the representative for Phillips, assured the Commission that the company would work cooperatively with the community to reduce impacts. I also assured the Commission that State Lands Commission and staff had given careful consideration to this exploratory program before authorizing it and that we would assist in mitigating any impacts on neighbors. Don Everitts has been notified of the situation.

The Commission approved three of the wells and continued consideration of the well closest to shore until the 2nd meeting in January.

In another action on November 17 Union Oil Company was denied consistency on two exploratory wells they proposed on OCS lease P-0203 within the Channel Islands Marine Sanctuary. Union Oil did little to defend their decision to drill. Minerals Management of the Department of Interior and the Coast Guard spoke in favor of the permit.
