AREA, TYPE LAND AND LOCATION:
0.501 acre parcel of tide and submerged
land in the Pacific Ocean at Long Point,
Palos Verdes Peninsula, Los Angeles County.

LAND USE: A pier for boat docking and salt water
intake system.

TERMS OF ORIGINAL LEASE:

Initial period: 15 years from December 1,
1977.

Renewal options: Two (2) successive periods
of 10 years each.

Surety bond: \$5,000.

Initial period: 15 years from December 1,
1977.

Renewal options: Two (2) successive periods
of 10 years each.

Surety bond: \$10,000.

Public liability insurance:
\$600,000 per occurrence
for bodily injury and
\$100,000 for property
damage, or combined single
limit coverage of \$700,000.

CONSIDERATION: \$4,365 per annum, with the State reserving
the right to fix a different rental on
each fifth anniversary of the lease.

BASIS FOR CONSIDERATION: Pursuant to 2 Cal. Adm. Code 2003.

PREREQUISITE TERMS, FEES AND EXPENSES:

Applicant is owner of upland.

Filing fee has been received.

STATUTORY AND OTHER REFERENCES:

OTHER PERTINENT INFORMATION:

1. On March 30, 1978, the Commission approved
a lease to Hanna-Barbera Marineland,
a partnership of Kroventure - Marineland
H.B., Inc., beginning December 1, 1977,
for a pier and salt water intake system.
On January 1, 1982, the upland and
park was purchased by the proposed

assignee, Marineland Amusements Corporation, who renamed the park "Marineland Amusements".

2. The proposed amendment will include the following:
 - a) Increase the annual rental to \$4,365, effective December 1, 1982, with the State reserving the right to fix a different rental on each fifth anniversary of the lease.
 - b) Provide for a surety bond in the amount of \$10,000.
3. This activity is exempt from CEQA because it is not a project which would have a significant effect on the environment; 14 Cal. Adm. Code, Section 15060.
4. The project is situated on lands identified as possessing significant environmental values pursuant to P.R.C. 6370.1 and is classified in a use category "C", which authorizes Multiple Use. The project as proposed will not have a significant effect upon the identified environmental values.

IT IS RECOMMENDED THAT THE COMMISSION:

1. DETERMINE THAT AN ENVIRONMENTAL DOCUMENT HAS NOT BEEN PREPARED FOR THIS ACTIVITY AS SUCH DOCUMENT IS NOT REQUIRED UNDER THE PROVISIONS OF ADM. CODE 15060, AND FIND THAT THE PROJECT IS CONSISTENT WITH THE USE CLASSIFICATION OF AFFECTED STATE LANDS;
2. AUTHORIZE THE ASSIGNMENT OF LEASE PRC 1395.1 TO MARINELAND AMUSEMENTS CORPORATION AND AMENDMENT OF SAID LEASE EFFECTIVE JANUARY 1, 1982; IN CONSIDERATION OF ANNUAL RENT IN THE AMOUNT OF \$4,365, BEGINNING DECEMBER 1, 1982, WITH THE STATE RESERVING THE RIGHT TO FIX A DIFFERENT

RENTAL ON EACH FIFTH ANNIVERSARY OF THE LEASE AND PROVISION OF A \$10,000 SURETY BOND; FOR A PIER FOR BOAT DOCKING AND SALT WATER INTAKE SYSTEM ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

3. ALL OTHER TERMS AND CONDITIONS OF LEASE P.R.C. 1395.1 TO REMAIN IN FULL FORCE AND EFFECT.


