OTHER PERTINENT INFORMATION:

1. Pursuant to a Letter of Permission approved by State Lands Commission at the May 27 1982 meeting the relocation of the submarine cable conduit has been completed.

The relocation was necessary due to Caltrans bridge construction. The new Right-of-Way is approximately 80 feet to the west of the existing permitted area which is to be terminated and Quitclaimed.

2. This project is exempt from CEQA because it is within the purview of 14 Cal. Adm. Code, Div. 6, Section 15104, which exempts minor alteration in the condition of land and water.
3. The project is situated on lands identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and is classified in use category "B" which authorizes Limited Use. The project as proposed will not have a significant effect upon the identified environmental values.




IT IS RECOMMENDED THAT THE COMMISSION:




