CANCELLATION OF APPLICAN
PROSPECTING PERMITS

AREA, TYPE LAND AND LOCATION:
16136 acres of sovereign lands in the beds
of Clear Lake and Thurston Lake, Lake County.

APPLICANTS: As listed in Exhibit "A" attached.

LOCATION: As indicated in Exhibit "B" attached.

BACKGROUND INFORMATION:
The eleven listed applications for geothermal
prospecting permits covering a substantial
portion of the bed of Clear Lake, Lake
County were filed over a period of years,
beginning in 1975, and extending into early
1981. None of the applicants submitted
a project description or made arrangements
for funding an appropriate environmental
document, although all had been advised
that such would be required before the
applications could be considered complete
and processed for approval. At a meeting
in Lakeport on July 9, 1981, attended by

a majority of the applicants, the requirements were reiterated, and some suggestions were offered toward their resolution. No responses were received. On February 22, 1983, the applicants were advised that a deposit of \$50,000 toward the cost of an environmental document plus a detailed proposal for a project must be received within 90 days, or the applications would be cancelled and advance rental deposits returned. The 90 day period has expired and no deposits or proposals have been received.



