DENIAL OF APPLICATION
FOR DIVERSION OF SPRING WATER FOR DOMESTIC USE

APPLICANTS: W 23037 - Ludi, Orquin and Reeser
W 23080 - Stan Heymann
W 23082 - Ursi Reynolds

AREA, TYPE LAND AND LOCATION:
A 40-acre parcel of State school land in the NW $\frac{1}{2}$ of the SW $\frac{1}{2}$ of Section 14, T3S R5E, HBM, near the town of Harris in Humboldt County.

BACKGROUND: The proposed point of diversion is a spring near the north property line of the State-owned 40-acre parcel. The subject property is on a steep north slope within the Chamise Creek drainage approximately one-half mile above the creek bed. Chamise Creek is considered a valuable spawning stream.

The staff circulated a Negative Declaration (SCH 83033012) in conformance with CEQA and the guidelines established by the Commission. Adverse comments received are:

CALENDAR ITEM NO. 1 (CONT'D)

Humboldt County Sheriff's Department: As the result of a raid in 1981, three of the applicants are under indictment for felony cultivation of marijuana on adjoining private land that was allegedly irrigated by water diverted from the State land without authorization. The Sheriff's Department destroyed the unauthorized pipeline during the 1981 raid; however, when staff visited the site in 1982, a new pipeline had been installed. The general vicinity has been ranked as the number three (3) marijuana-growing area in Humboldt County.

The Sheriff's Office recommended against non-law enforcement people investigating this site in light of recent occurrences in this area, including eight drug-related murders, five shootings at recreationalists (three wounded), and the use of Claymore mines to protect the growing areas.

Department of Fish and Game: Fish and Game has determined that the proposed diversion could capture the entire flow of the spring, which would adversely affect wildlife habitat. The elimination of this spring would affect the resident animals, migrating animals and may be detrimental to the valuable spawning areas in Chamise Creek.

Fish and Game also is of the opinion there is a significant probability of an increase in killing of deer and other animals to reduce crop losses by persons who use the diverted water for "unspecified agricultural purposes".

IT IS RECOMMENDED THAT THE COMMISSION:

1. DENY THE THREE APPLICATIONS (W 23037, W 23080 AND W 23082) FOR THE DIVERSION OF SPRING WATER FOR DOMESTIC USE, ON A 40-ACRE PARCEL OF SCHOOL LAND IN THE NW $\frac{1}{2}$ SW $\frac{1}{2}$ OF SECTION 14, T5S R5E, HBM, NEAR THE COMMUNITY OF HARRIS IN HUMBOLDT COUNTY.
2. AUTHORIZE THE EXECUTIVE OFFICER TO REQUEST THAT STATE AND LOCAL LAW ENFORCEMENT PERSONNEL INSPECT THE SCHOOL LAND ON A REGULAR BASIS TO DETERMINE WHETHER OR NOT IT IS BEING USED TO CULTIVATE OR IRRIGATE MARIJUANA, AND TO TAKE APPROPRIATE REMEDIAL ACTION IF NECESSARY.


