DREDGING PERMIT

APPLICANT: American Bridge
105 Oyster Point Levard
South San Francisco California 94080

AREA, TYPE LAND AND LOCATION:
Tide and submerged lands at the Hunters
Point Fabrication Yard, Hunters Point in
San Francisco Bay, County of San Francisco.

LAND USE: Dredge a total of 90,000 cubic yards of
material from the project area with 35,000
cubic yards to be removed from State-owned
lands for an existing dock area for access
by barge traffic used to transport platform
components. Dredging was last conducted
in 1945, siltation has reduced depths at
the facility from -45 feet MLLW to -18
feet MLLW. Spoils to be deposited at the
United States Corps of Engineers (C.O.E.)
Disposal Site S.F. 11, Alcatraz.

TERMS OF PROPOSED PERMIT:
Period: For a period of one year from
date of Commission action.

CONSIDERATION: A royalty of \$0.15 per cubic yard to be
charged for spoils placed at the C.O.E.
approved disposal site S.F. 11 near Alcatraz

and a royalty of \$0.25 per cubic yard for spoils placed on private property or sold for commercial benefit.

3. This project is situated on State lands identified as possessing significant environmental value pursuant to P.R.C. 6370.1 and is classified in use category class "C", Multiple Use.

IT IS RECOMMENDED THAT THE COMMISSION:

1. DETERMINE THAT AN ENVIRONMENTAL DOCUMENT HAS NOT BEEN PREPARED FOR THIS ACTIVITY AS SUCH DOCUMENT IS NOT REQUIRED UNDER THE PROVISIONS OF P.R.C. 21084, 14 CAL. ADM. CODE 15100 ET. SEQ., AND 2 CAL. ADM. CODE 2905.
2. FIND THAT THIS ACTIVITY IS SITUATED ON LAND IDENTIFIED AS POSSESSING ENVIRONMENTAL VALUES PURSUANT TO P.R.C. 6370.1 AND THAT THIS ACTIVITY IS COMPATIBLE WITH THAT FINDING AS IT APPLIES TO THE SUBJECT LAND.

3. AUTHORIZE THE ISSUANCE TO AMERICAN BRIDGE OF A ONE-YEAR DREDGING PERMIT FROM SEPTEMBER 1, 1983 WITH A ROYALTY OF \$0.15 PER CUBIC YARD TO BE CHARGED FOR SPOILS PLACED IN THE C.O.E. APPROVED DISPOSAL SITE S.F. 11 NEAR ALCATRAZ ISLAND AND A ROYALTY OF \$0.25 PER CUBIC YARD FOR SPOILS PLACED ON PRIVATE PROPERTY OR SOLD FOR COMMERCIAL BENEFIT.







EXHIBIT "B"
