LETTER OF PERMISSION - YUBA-SUTTER DISPOSAL, INC. W 23135  
PRC 6483

A LETTER OF PERMISSION WAS GRANTED TO YUBA-SUTTER DISPOSAL, INC., PRELIMINARY TO A ROUTINE PERMIT, TO ENTER UPON SUBMERGED LAND IN THE YUBA RIVER, YUBA COUNTY, FOR REMOVAL OF FILL TO REPAIR AND MAINTAIN PASSABLE ACCESS TO THE FACILITY'S LAND FILL AREA.

THE GRANTED PERMISSION WAS AN INTERIM MEASURE PRECEDING ACTUAL APPROVAL OF THE COMMISSION.

THE APPLICANT HAS APPLIED FOR A PERMIT; HOWEVER, THE DEPARTMENT OF FISH AND GAME REQUIRES THE WORK TO BE COMPLETED BY SEPTEMBER 1, 1983, AND THE PERMITTING PROCESS PRECLUDES TIMELY APPROVAL.

THIS IS AN EMERGENCY PROJECT BECAUSE IT INVOLVES EMERGENCY REPAIRS TO PUBLIC SERVICE FACILITIES NECESSARY TO MAINTAIN SERVICE. AUTHORITY: 14 CAC, Div. 6, SEC. 15071.

THE AUTHORITY HAS AGREED TO OBTAIN A GENERAL PERMIT-  
PUBLIC AGENCY USE IN ACCORDANCE WITH COMMISSION RULES AND  
REGULATIONS, APPROVAL FOR THE PROJECT HAS BEEN RECEIVED FROM  
U. S. CORPS OF ENGINEERS, CALIFORNIA DEPARTMENT OF FISH AND  
GAME, AND THE CONTRA COSTA COUNTY FLOOD CONTROL DISTRICT. A FINAL  
EIR HAS ALSO BEEN CIRCULATED THROUGH THE STATE CLEARINGHOUSE

BCPUD AND BBCA HAVE REQUESTED PERMISSION FOR GROIN  
RECONSTRUCTION AND BULKHEAD REPLACEMENT ALONG BOLINAS BEACH,  
BOLINAS, MARIN COUNTY.

IN RESPONSE TO THE BCPUD AND THE BBCA'S DESIRE TO COMPLETE  
THIS PROJECT PRIOR TO THE WINTER STORMS IN ORDER TO INSURE  
THE SAFETY AND PROTECTION OF BEACH USERS, RESIDENTS, HOMES,  
UTILITIES AND ROADWAYS, I HAVE ISSUED A LETTER AUTHORIZING THE  
ABOVE-MENTIONED WORK.

THE BCPUD AND THE BBCA HAVE AGREED TO OBTAIN A GENERAL  
PERMIT - PROTECTIVE STRUCTURE IN ACCORDANCE WITH COMMISSION  
RULES AND REGULATIONS. THE PROJECT HAS RECEIVED FUNDING FROM  
CAL BOATING, THE SAN FRANCISCO FOUNDATION AND MARIN COUNTY  
DEPARTMENT OF PARKS AND RECREATION. THE COASTAL COMMISSION  
AND THE CORPS OF ENGINEERS HAVE AGREED TO EXPEDITE THE PERMIT  
APPLICATION ON AN EMERGENCY OR "REDUCED PROCEDURE" BASIS,  
RESPECTIVELY.
