BACKGROUND: On June 23, 1981, the State Lands Commission approved the issuance of a General Lease - Commercial Use, covering a 2.72-acre parcel of tide and submerged lands in the Sacramento River, Sacramento County, for operation and maintenance of a commercial marina, to William W. and Ann D. Cameron.

CURRENT SITUATION:
Lessee has applied to Imperial Thrift and Loan Association for a loan to improve the leased premises under PRC Lease 6027.1. As a condition for the loan, the Association has requested that it be named as a secured party-lender under the subject lease. Lessee

1. This activity is exempt from CEQA because it can be seen with certainty that there is no possibility that this project may have a significant effect on the environment.

2. The activity is situated on lands identified as possessing significant environmental values pursuant to P.R.C. 6027.1 and is classified in a use category "B" which authorizes Limited Use. The activity as proposed will not have a significant effect upon the identified environmental values.

DETERMINE THAT AN ENVIRONMENTAL DOCUMENT HAS NOT BEEN PREPARED FOR THIS ACTIVITY AS SUCH DOCUMENT IS NOT REQUIRED UNDER THE PROVISIONS OF P.R.C. 21065, AND 14 CAL. ADM. CODE 15061, AND FIND THAT THE PROJECT IS CONSISTENT WITH ITS USE CLASSIFICATION.
2. AUTHORIZE THE AGREEMENT AND CONSENT TO ENCUMBRANCING OF LESSEE'S RIGHTS, TITLE AND INTERESTS IN LEASE PRC 6027.1 IN FAVOR OF IMPERIAL THRIFT AND LOAN ASSOCIATION; FOR THE PURPOSE OF OBTAINING A LOAN TO IMPROVE THE LEASED PREMISES UNDER PRC LEASE 6027.1.


