CONSTRUCTION: Filing fee of \$25 and an expense deposit
of \$100.

TERM: The primary term of these Geological/Geophysical


A. Map of four permit regions.

2. AUTHORIZE ISSUANCE OF NON-EXCLUSIVE GENERAL PERMITS TO CONDUCT GEOLOGICAL/GEOPHYSICAL SURVEYS IN REGIONS I, II, III AND IV TO EG&G INTERNATIONAL, INC. (EG&G ENVIRONMENTAL CONSULTANTS DIVISION) FOR A TERM OF FOUR MONTHS.
