Approval of Geological/Geophysical Survey
Permits for four (4) months to gather geological
and geophysical data on mineral resources
(excluding rotary core drilling) on tide

CONSTRUCTION: Filing fee of \$25 and an expense deposit
of \$100.

TERM: The primary term of these Geological/



2. AUTHORIZE ISSUANCE OF NON-EXCLUSIVE GENERAL PERMITS TO CONDUCT GEOLOGICAL/GEOPHYSICAL SURVEYS IN REGIONS I, II, III AND IV TO DAMES AND MOORE FOR A TERM OF FOUR MONTHS.
