EMERGENCY LETTER OF PERMISSION  
FARIA BEACH HOMEOWNER'S ASSOCIATION

Faria Beach Homeowner's Association has requested permission for construction of an along-shore reef at Faria Beach, Ventura County.

In response to the Association's desire to complete this project prior to the winter storms and in order to insure the safety and protection of beach users, residents, and homes, I have issued a letter authorizing the above-mentioned work.

The Association has agreed to obtain a General Permit Protective Structure in accordance with Commission rules and regulations and to enter into any necessary boundary agreements. The Association has further agreed to obtain the necessary approval of all affected State, Federal or local agencies. The State Coastal Commission has advised the homeowners that they must secure permission of the State Lands Commission before its permit processing can begin.

The project is exempt from CEQA as it involves actions necessary to prevent an emergency pursuant to 14 CAC, Div. 6, Section 15269(c).

This project is situated on land identified as possessing environmental values in that the State Lands Commission stated all waterways under the Commission's jurisdiction have environmental significance. The Commission staff finds this project to be compatible with Commission policy.

PG&E Master Lease                      PRC 6205.1

Calendar Item 19 of the August 26, 1982 Commission meeting authorized the Executive Officer to approve minor modifications to Pacific Gas and Electric Company's Master Lease PRC 6205.1, General Lease - Right of Way Use, for electrical distribution lines statewide.

The second amendment to PRC 6205.1 is a 1.05-acre parcel of submerged land in the Sacramento River at Butte City, Glenn County, on which distribution lines will be relocated from an 0.84-acre parcel located 1,500 feet upriver that was deleted from the lease.

This is a categorical exemption because it involves minor alteration to land and water. Authority: 14CAC Div 6, Section 15304.
