EXTENSION OF INITIAL DRILLING TERM,  
STATE OIL AND GAS LEASE PRC 6094.1

AREA, TYPE LAND AND LOCATION:

State Oil and Gas Lease PRC 6094.1 was  
issued by the Commission on December 17,  
1981, and contains approximately 400 acres  
of tide and submerged land in the bed of  
the San Joaquin River and False River,  
Contra Costa and Sacramento Counties.

SUMMARY:

State Oil and Gas Lease PRC 6094.1 is presently  
under the original drilling term of two  
(2) years which expires December 17, 1983.  
The lessees have requested that the Commission  
extend this term one (1) additional year  
due to delays caused by storms and flooding  
in the area during the past year, which  
prevented the lessees from using upland  
drillsites.

PREREQUISITE TERMS:

The lessees will deposit the additional year's rental of \$8,000 and will maintain the lease bond of \$50,000 to guarantee the faithful performance of all provisions of this lease.
