1. Assignor sold the marina properties to assignees on November 1, 1983, and now requests that the Commission approve an assignment of Lease PRC 6372.1.
2. This activity is exempt from CEQA because it does not constitute a project pursuant to 14 CAC, Section 15378.
3. The marina project is situated on lands identified as possessing significant environmental values pursuant to P.R.C. 6370.1 and is classified in a use category "B" which authorizes Limited Use. The assignment will not have a significant effect upon the identified environmental values.

IT IS RECOMMENDED THAT THE COMMISSION:

1. FIND THAT THIS ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CALIFORNIA ENVIRONMENTAL QUALITY ACT BECAUSE THE ACTIVITY IS NOT A PROJECT AS DEFINED BY P.R.C. 21065, 14 CAL. ADM. CODE 15378; AND FIND THAT THE ACTIVITY IS CONSISTENT WITH THE LAND'S USE CLASSIFICATION, PURSUANT TO PRC 6370.1.
2. AUTHORIZE ASSIGNMENT TO GENE K. AND CARROL A. CARTWRIGHT OF LEASE PRC 6372.1, EFFECTIVE NOVEMBER 1, 1983; ALL TERMS AND CONDITIONS OF LEASE PRC 6372.1 REMAIN UNCHANGED ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

A parcel of tide and submerged land situated in the bed of the Sacramento River, T8N, R4E, MDM, Yolo County, California, being all that land lying immediately beneath the existing structures together with a use area, said parcel being more particularly described as follows:

BEGINNING at a point which bears N 55° 37' 39" E 1935.25 feet from USGS Horizontal Control Station Pier 20, Pier 20 being a USGS bench mark disk set in top of a large concrete block projecting 2.3 feet above the ground; thence from said point of beginning the following 24 courses:


