APPROVAL OF TERMINATION OF GENERAL PERMIT -
INDUSTRIAL USE (PRC 5686.1)

LESSEE: Pacific Refining Company
9 Greenway Plaza
Houston, Texas 77046

BACKGROUND: On June 27, 1979, the Commission approved
(Minute Item No. 15) a permit for the placement
of a buoy to moor an oil spill emergency
response vessel in San Pablo Bay, Contra
Costa County, to Pacific Refining Company.

CURRENT SITUATION:

On November 25, 1983, staff was advised,
by letter dated November 15, 1983, of Pacific's
desire to terminate the permit as of January 31,
1984. Berthing for oil spill emergency
response vessels has been provided at Union
Oil's dock in San Pablo Bay. Therefore,
the permitted buoy was never installed
and leased land is still unimproved.

Lessee has complied with all of the provisions
contained within Paragraph 22 (Termination
by Lessee) of Section 5, PRC 5686.1).

OTHER PERTINENT INFORMATION:

This activity is exempt from CEQA because it is not a project under the provisions of P.R.C. 21065, 14 Cal. Adm. Code 15378.

This activity is situated on lands identified as possessing significant environmental values pursuant to PRC 6370.1 and is classified in Use Category "B" which authorizes limited use. This activity as proposed will not have a significant effect upon the identified environmental values.


