CONSIDERATION OF ASSIGNMENT  
OF ROYALTY OIL SALES CONTRACT  
FROM POWERINE OIL COMPANY  
HUNTINGTON BEACH, ORANGE COUNTY

During consideration of Calendar Item 1, attached, Commission-Alternate Walter Harvey made a statement regarding the financial status of Powerine Oil Company. The attorney representing Powerine in their bankruptcy filing is Herbert Young, General Counsel, 12354 Lakeland Road, Santa Fe Springs, California 90670.

ASSIGNMENT OF ROYALTY OIL SALES CONTRACT  
STATE OIL AND GAS LEASE PRC 426,  
HUNTINGTON BEACH FIELD, ORANGE COUNTY

SUMMARY:

Issuance of Royalty Oil Sales Contract PRC 6480 to Powerine Oil Company for a term of 18 months commencing November 1, 1983, was authorized by the Commission on August 25, 1983. The contract was based on competitive public bid (6 bidders) with bonus bids in dollars per barrel above the base price. The base price is the highest price posted for oil of like gravity and quality in the Huntington Beach Field on the day of the delivery. Powerine was the highest responsible bidder with a bid of \$2.121.

Powerine has submitted a non-conditional assignment and assumption of contract form effective April 1, 1984, and has requested State Lands Commission approval.

PREREQUISITE ITEMS:

- A. Assignment forms have been executed by assignor and assignee and are on file in the Long Beach Office of the Commission.
- B. Assignee is eligible to hold a State Royalty Oil Sales Contract.

CONSENT TO THE ASSIGNMENT OF ALL OF THE ASSIGNOR'S (POWERINE OIL COMPANY) INTEREST IN ROYALTY OIL SALES CONTRACT STATE OIL AND GAS LEASE PRC 426, HUNTINGTON BEACH FIELD TO THE ASSIGNEE (EDGINGTON OIL COMPANY, INC.), EFFECTIVE APRIL 1, 1984, WITH THE ASSIGNEE TO BE BOUND BY THE TERMS AND CONDITIONS OF THE CONTRACT TO THE SAME ENTENT AS THE ORIGINAL PURCHASER UNDER THE CONTRACT, PROVIDED THAT NOTHING IN THE ASSIGNMENT OR IN THE STATE'S CONSENT TO IT ABROGATES THE RESPONSIBILITY OF POWERINE TO PAY FOR ROYALTY OIL DELIVERED TO POWERINE PRIOR TO APRIL 1, 1984, AND THE OBLIGATIONS OF THE SURETY TO GUARANTEE SUCH PAYMENT.
