DREDGING PERMIT

APPLICANT: City of Santa Barbara
735 Anacapa Street
P. O. Box Drawer P-P
Santa Barbara, California 93102

AREA, TYPE LAND AND LOCATION:
Tide and submerged lands granted to the City of
Santa Barbara with minerals reserved to the
State in Santa Barbara Harbor small boat basin,
east jetty boat ramp and along west
breakwater. Santa Barbara County, California.

LAND USE: Dredge a total of 160,000 cubic yards of
sediments to maintain safe navigation within
the harbor and small boat sailing basin.

Spoils taken from the harbor will be
transferred to the East Beach surf zone as the
primary disposal site to encourage beach
nourishment.

Leadbetter Beach, adjacent to the west
breakwater and the seaward side of the west
breakwater may serve as emergency alternate
disposal sites.

TERMS OF PROPOSED PERMIT::
Initial period five years from March 1, 1984.

CONSIDERATION. No royalty is to be charged for spoils placed
on publicly owned lands and beaches. A royalty
of \$0.25 per cubic yard will be charged for
spoils placed on private property or sold for
commercial benefit.

PREREQUISITE CONDITIONS, FEES AND EXPENSES:
Filing fee has been received.

OTHER PERTINENT INFORMATION:

1. City of Santa Barbara, Public Works has applied for a dredging permit to remove up to 160,000 cubic yards of material from Santa Barbara Harbor west breakwater, east jetty boat ramp, and small boat sailing basin. The material will be deposited on the East Beach surf zone as primary disposal site and an alternate disposal site at the riprap on Leadbetter Beach or the seaward side of the west breakwater in an emergency.
2. This project involves lands (minerals reserved to the State) identified as possessing significant environmental value pursuant to P.R.C. 6370.1 et seq. Based upon the staff's consultation with the persons' nominating such lands and through the CEQA review process, it is the staff's opinion, that the project, as proposed, is consistent with its use classification.
3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under (Class 4(g) maintenance dredging, 14 Cal. Adm. Code 15304) authority: PRC 21084 and (14 Cal. Adm. Code 15300).

IT IS RECOMMENDED THAT THE COMMISSION:

1. FIND THAT THE ACTIVITY IS EXEMPTED FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. ADM. CODE 15061 AS A CATEGORICALLY EXEMPT PROJECT CLASS 4(9), MAINTENANCE DREDGING 14 CAL. ADM. CODE 15304.
2. FIND THAT THIS ACTIVITY, AS PROPOSED, IS CONSISTENT WITH THE USE CLASSIFICATION DESIGNATED FOR THE LANDS PURSUANT TO P.R.C. 6370 ET SEQ.
3. AUTHORIZE ISSUANCE TO THE CITY OF SANTA BARBARA A FIVE-YEAR DREDGING PERMIT FROM MARCH 1, 1984, IN CONSIDERATION OF NO ROYALTY CHARGED FOR SPOILS PLACED ON EAST BEACH OR LEADBETTER BEACH OR THE BREAKWATER. A ROYALTY OF 25 CENTS PER CUBIC YARD WILL BE CHARGED FOR SPOILS PLACED ON PRIVATE PROPERTY OR SOLD FOR COMMERCIAL BENEFIT.




