TENTH MODIFICATION

1983-84 PLAN OF DEVELOPMENT AND OPERATIONS AND BUDGET  
LONG BEACH UNIT, WILMINGTON OIL FIELD  
LOS ANGELES COUNTY

The City of Long Beach, as Unit Operator, has requested approval of the Tenth Modification of the 1983-84 Plan of Development and Operations and Budget, Long Beach Unit. This modification would provide for installation of a liquid meter and a capacitance probe on each of the four THUMS oil islands for the purpose of metering the total oil and water emulsion transferred from each island to Pier J.

The system would check the accuracy of the automatic well tests on a per island basis rather than on the total produced volumes as is done currently. More accurate production tests would also enhance voidance calculations for monitoring subsidence control.

The \$188,000 estimated project costs would be provided in Oil and Gas Production Program Account 404 (Oil Gathering) by a transfer within the existing budget so no augmentation of funds would be required; the total revised budget would remain \$258,657,453. Funds are available in the same program Account 915(B) (Gas Transfer) due to deferment of gas lines relocation caused by postponement of the Long Beach Harbor Department's coal terminal project.

IT IS RECOMMENDED THAT THE COMMISSION APPROVE THE TENTH MODIFICATION OF THE 1983-84 PLAN OF DEVELOPMENT AND OPERATIONS AND BUDGET, LONG BEACH UNIT.

Also, in accordance with Part IV A.4a and 4.c of the 1983-'84 Plan of Development and Operations and Budget, Long Beach Unit, Plan Supplement No. 7 for an additional project under \$100,000 has been approved by the Director of Oil Properties, City of Long Beach and the Chief, Extractive Development Program, State Lands Commission. It is hereby reported to the Commission and incorporated into the Plan. This reporting requires no action by the Commission.
