SUMMARY:

Issuance of Royalty Oil Sales Contract PRC 6497 to Paramount Petroleum Corporation (formerly Pacific Oasis) for a term of 18 months commencing December 1, 1983, and was authorized by the Commission on September 28, 1983. The contract was based on competitive public bid (11 bidders) with bonus bids in dollars per barrel above the base price. The base price is the highest price posted for oil of like gravity and quality in Huntington Beach Field on the day of the delivery. Paramount was the highest responsible bidder with a bid of \$2.057..

Paramount has submitted a non-conditional assignment and assumption of contract form effective July 1, 1984, and has requested State Lands Commission approval.

PREREQUISITE ITEMS:

- A. Assignment forms have been executed by assignor and assignee and are on file in the Long Beach Office of the Commission.
- B. Assignee is eligible to hold a State Royalty Oil Sales Contract.
- C. Performance bond (\$1,000,000) will be submitted before oil deliveries commence.
