APPROVAL OF A GENERAL PERMIT -

APPLICANT:

County of Glenn

CALENDAR ITEM NO. 03 (CONT'D)

OTHER PERTINENT INFORMATION:

1. County of Glenn proposes to construct a public launching facility comprised of a one-lane ramp, paved parking and access area, portable sanitary facilities, a boarding float and other ancillary facilities. The site is an existing unmaintained slough which provides a direct channel to the main river channel. Because staff has not performed study of that reach of the river, the state's ownership claim is undetermined. The lease terms provide that the State is leasing whatever right, title or interest it possesses; therefore staff recommends that the processing expense fee be waived.
2. The annual rental value of the site is estimated to be \$250.00.
3. A Negative Declaration was prepared and adopted for this project by Glenn County. The State Lands Commission's staff has reviewed such document and believes that it complies with the requirements of the CEQA.
4. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

AUTHORIZE ISSUANCE TO COUNTY OF GLENN OF A 49-YEAR GENERAL PERMIT - PUBLIC AGENCY USE BEGINNING OCTOBER 1, 1984: IN CONSIDERATION OF THE PUBLIC USE AND BENEFIT WITH THE STATE RESERVING THE RIGHT AT ANY TIME TO SET A MONETARY RENTAL IF THE COMMISSION FINDS SUCH ACTION TO BE IN THE STATE'S BEST INTEREST; WAIVE PROCESSING FEE FOR CONSTRUCTION AND MAINTENANCE OF A PUBLIC BOAT LAUNCHING FACILITY ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.
