APPROVAL OF AMENDMENT TO  
STATE OIL AND GAS LEASE PRC 2933,  
SANTA BARBARA COUNTY

AREA, TYPE LAND AND LOCATION:

State Oil and Gas Lease PRC 2933 contains  
approximately 4,250 acres of tide and submerged  
lands located offshore Tajiguas in Santa  
Barbara County, California.

PERTINENT INFORMATION:

Resumption of drilling operations on the  
subject lease was authorized by the Commission  
on 1982, and since that time two wells have  
been drilled and a significant new gas  
discovery made. Phillips has received  
permission from the County to process the gas  
at the existing Tajiguas gas processing plant.

The lease currently has one producing well and  
the lessees desire to have the flexibility to  
shut in the well for various technical reasons,

primary of which is the necessity of renovating the current gas processing plant at Tajiguas in order to process gas produced by recently drilled wells.

In consideration for the suspended gas production, the lessee will pay monthly, \$25,000 to the State, as compensatory royalty, until (1) production is reestablished from the single well; (2) oil and/or gas is being produced from other wells on the lease; (3) the lessees exercise their rights to quitclaim the lease or (4) October 28, 1985, whichever is sooner. The payment of compensatory royalty for the suspended gas production together with compliance with all other terms and conditions of the lease, including the drilling obligations of Exhibit "A" of the lease, will maintain the lease in full force and effect. The amendment has been executed by the lessees. The amendment does not grant the lessees any rights or interests not otherwise granted by the lease.

Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061) the staff has determined that this activity is exempt from the requirements of the CEQA because it is not a "project" as defined by CEQA and the State CEQA Guidelines.

AUTHORIZE EXECUTION OF THE AMENDMENT TO STATE OIL AND GAS LEASE PRC 2933 WHICH IS ON FILE IN THE OFFICE OF THE COMMISSION AND MADE A PART HEREOF, TO PROVIDE FOR THE TEMPORARY SUSPENSION OF GAS PRODUCTION FROM THE LEASE, AND FOR THE PAYMENT OF COMPENSATORY ROYALTY AT THE RATE OF \$25,000 PER MONTH, UNTIL GAS PRODUCTION IS COMMENCED FROM THE EXISTING PRODUCING WELL OR OTHER WELLS DRILLED ON THE LEASE, UNTIL THE LEASE IS PROPERLY QUITCLAIMED OR UNTIL OCTOBER 28, 1985, WHICHEVER IS SOONER.


