AREA, TYPE LAND AND LOCATION:

State Oil and Gas Lease PRC 6669 contains 919
acres (more or less) of State-owned lands which
are included in the Tule Elk State Reserve and
located about twenty miles west of Bakersfield
in Kern County.

SUMMARY:

State Oil and Gas Lease PRC 6669 was issued by
the State Lands Commission on May 24, 1984, for
a primary term of twenty years. No wells have
been drilled on or into the leased lands.

In accordance with paragraph 6 of the lease,
the Lessee may make a written quitclaim of all
or any portion of the leased lands and such
quitclaim shall be effective when it is filed
with the State; however, it shall not release
the Lessee from any liability or breach of any
obligation of this lease with respect to which
the Lessee is in default at the time of the
filing of the quitclaim.

On April 8, 1985, staff received a quitclaim and surrender document dated March 21, 1985 and signed by Corbin J. Robertson, terminating all his right, title and interest in and to State Oil and Gas Lease PRC 5669.

- B. California Division of Oil and Gas records and drilling reports on the surrounding area have been reviewed by staff for compliance with lease terms, State laws and regulations.



THE ABOVE DESCRIBED EIGHT PARCELS OF STATE LANDS COVER AN AREA OF 919 ACRES,
