AREA, TYPE LAND AND LOCATION:

State Oil and Gas Lease PRC 2726 contains
approximately 4250 acres of tide and submerged
lands, located about seven miles east of
Pt. Conception in the Santa Barbara Channel, in
Santa Barbara County.

LEASE SUMMARY:

State Oil and Gas Lease PRC 2726 was issued on
May 4, 1961, to Richfield Oil Corporation (now
Atlantic Richfield Company), the Ohio Oil
Company (now Marathon Oil Company), Socony
Mobil Oil Company, Inc. (now Mobil Oil
Corporation) and Tidewater Oil Company (now
Getty Oil Company) pursuant to competitive
public bidding. Atlantic Richfield is
presently the operator and has submitted an
application to resume drilling operations on
State Lease PRC 2726.

Executed assignment forms have been filed by
Getty Oil Company (Assignor) and Texaco
Producing Inc. (Assignee) pursuant to P.R.C.
Section 6804 and Section 4 of the lease, and

they have requested that the State Lands Commission consent to the assignment of all Assignor's interest in State Oil and Gas Lease PRC 2726 to Assignee.

- B. Assignee is qualified to hold a State lease.
- C. Filing fee and processing costs have been received.





