GENERAL PERMIT - PUBLIC AGENCY USE

APPLICANT: State Reclamation Board
Attn: Robert Manning
1416 Ninth Street
Sacramento, California 95814

AREA, TYPE LAND AND LOCATION:
A 1.717-acre parcel of submerged land in the
bed of the Sacramento River at River Mile 236.7.

LAND USE: Palisades demonstration bank erosion control
project.

TERMS OF PROPOSED PERMIT:
Initial period: Five years beginning
August 1, 1985.

CONSIDERATION: The public use and benefit; with the State
reserving the right at any time to set a
monetary rental if the Commission finds such
action to be in the State's best interest.

BASIS FOR CONSIDERATION:
Pursuant to 2 Cal. Adm. Code 2003.

APPLICANT STATUS:
Applicant is presently negotiating for
permission to use the upland. Evidence of
permission must be provided to the State Lands
Commission prior to construction.

PREREQUISITE CONDITIONS, FEES AND EXPENSES:
Filing fee and processing costs have been
received.

OTHER PERTINENT INFORMATION:

1. The State Reclamation Board proposes to install a palisade system for bank protection. The system consists of a series of nets composed of close weave polyester attached to pilings which are placed generally perpendicular to the shoreline at regular 30 foot intervals. The system will run approximately 2,200 feet along the right bank at Sacramento River Mile 236.7.
2. The palisade system is being installed as a demonstration project. The Reclamation Board is working with the California Department of Fish and Game and the United States Fish and Wildlife Service to develop a monitoring/research program which will evaluate the impacts and effectiveness of the palisade system as a bank erosion control device. The lease provides that the monitoring program be approved by the State Lands Commission and the Department of Fish and Game prior to any construction and that the results of the program be provided to the Commission. The Commission will also be provided with a copy of any monitoring reports submitted to the Reclamation Board by the contractor for this project.

The applicant has informed the staff that the right bank at River Mile 236.7 was chosen for this demonstration project because it is the most difficult site to correct for erosion problems. The staff has informed the applicant that because it is such a difficult site, it should not

necessarily be used as an indicator of the effectiveness of the Palisades at other sites on the River.

3. The annual rental value of the site is estimated to be \$1,000.
4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorical exempt project. The project is exempt under Class 6, Information Collection, 14 Cal. Adm. Code 15306.

Authority: P.R.C. 21084, 14 Cal. Adm. Code 15300.

5. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

IT IS RECOMMENDED THAT THE COMMISSION:

1. FIND THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. ADM. CODE 15061 AS A CATEGORICAL EXEMPT PROJECT, CLASS 6, INFORMATION COLLECTION, 14 CAL. ADM. CODE 15306.
2. FIND THAT THIS ACTIVITY IS CONSISTENT WITH THE USE CLASSIFICATION DESIGNATED FOR THE LAND PURSUANT TO P.R.C. 6370, ET SEQ.

AUTHORIZE ISSUANCE TO STATE RECLAMATION BOARD OF A FIVE-YEAR GENERAL PERMIT - PUBLIC AGENCY USE BEGINNING AUGUST 1, 1985; IN CONSIDERATION OF THE PUBLIC BENEFIT, WITH THE STATE RESERVING THE RIGHT AT ANY TIME TO SET A MONETARY RENTAL IF THE COMMISSION FINDS SUCH ACTION TO BE IN THE STATE'S BEST INTEREST; FOR INSTALLATION AND MAINTENANCE OF A DEMONSTRATION PALISADE SYSTEM ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

All that submerged land in the bed of the Sacramento River lying immediately beneath bank protection facilities as shown on Ercon Corporation construction drawing No. 11105-1, a copy of which is on file with the State Lands Commission, said facilities being located along 2200 feet of the right bank of the Sacramento River at Mile Post 236.7, approximately three miles north of Gerber, Tehama County, California, and in projected Section 18, T26N, R2W, MDM.


