DREDGING PERMIT, MOSS LANDING HARBOR DISTRICT,  
MONTEREY COUNTY

PERMITTEE: Moss Landing Harbor District  
P. O. Box 10  
Moss Landing, California 95039

AREA, TYPE LAND, LOCATION:  
Granted submerged lands on the bed of Moss  
Landing Harbor, Monterey County.

OTHER PERTINENT INFORMATION:

On February 24, 1977 (Minute Item 32) the State Lands Commission delegated authority to the Executive Officer for the issuance of dredging permits of 10,000 cubic yards or less. In accordance with that delegation, Moss Landing Harbor District was granted approval to perform maintenance dredging on granted submerged lands with minerals reserved to the State in Moss Landing Harbor. In accordance with said delegation of authority, it has been determined that the following conditions have been met.

1. The proposed project is categorically exempt from the requirements of CEQA under Class 4, Maintenance Dredging, 14. Cal. Adm. Code 15304(g).
2. The proposed project is consistent with the use classification designated for land pursuant to P.R.C. 6370 et. seq.
3. The amount to be dredged will not exceed 10,000 cubic yards.

4. A charge of \$0.25 per cubic yard will be assessed for spoil material that is deposited on private property elsewhere or sold commercially.
5. The approval of the project is contingent upon approval by all pertinent State, Federal and Local agencies.

LAND USE:

Dredge up to 10,000 cubic yards of sediments over a ten year period to maintain safe navigable depths and mooring within the Harbor. Spoils are to be deposited at authorized sites on an adjacent harbor district-owned beach waterward of the mean high water mark and at the United States Army Corps of Engineers approved disposal site S. F. 12 off Sandholdt Pier. No royalty will be charged for spoils placed at the S. F. 12 disposal site as the project is for public benefit.

TERMS OF PERMIT:

Initial Period: Ten years commencing August 1, 1985.

CONSIDERATION:

Pursuant to (2) Cal. Adm. Code 2003, no royalty will be charged for spoils placed on publicly-owned lands as the project is for the public benefit. A royalty of \$0.25 per cubic yard will be charged for spoils placed on privately-owned property or sold for commercial benefit.

PREREQUISITE TERMS, FEES, EXPENSES:

Filing fee has been received.






