GENERAL PERMIT - PUBLIC AGENCY USE, CITY OF IMPERIAL BEACH PRC 2405.9

ON SEPTEMBER 15, 1984, (MINUTE ITEM 17), THE STATE LANDS COMMISSION AUTHORIZED THE ISSUANCE OF A 49-YEAR GENERAL PERMIT-PUBLIC AGENCY USE, PRC 2405.9, TO THE CITY OF IMPERIAL BEACH, FOR THE CONSTRUCTION OF A BREAKWATER AND THE EXTENSION OF AN EXISTING GROIN TO CONNECT TO THE BREAKWATER. DUE TO LITIGATION REGARDING THE PROJECT, WHICH HAS NOW BEEN CONCLUDED IN FAVOR OF THE PROJECT, THE CITY WILL BE UNABLE TO MEET THE CONSTRUCTION COMPLETION DATE OF OCTOBER 1, 1985. THE CITY HAS REQUESTED THAT THE CONSTRUCTION COMPLETION DATE BE AMENDED AS FOLLOWS:

CONSTRUCTION SHALL BE COMPLETED NO LATER THAN OCTOBER 14, 1987.

A CALENDAR ITEM WILL BE PRESENTED TO THE COMMISSION FOR APPROVAL AT THE OCTOBER 24, 1985 COMMISSION MEETING.
