AMENDMENT OF AUTHORIZATION OF MINUTE ITEM NO. 1  
MEETING OF SEPTEMBER 4, 1984

PARTY: Riverboat Delta King,  
a Partnership

BACKGROUND:

At a special meeting of the State Lands Commission held on September 4, 1984 the Commission authorized issuance of a two year permit for the purpose of mooring the "Delta King" at a site in the Sacramento River at the old River Lanes Pier. The purpose of this location was to provide a site for restoration work on the "Delta King" riverboat. The staff originally proposed a \$400,000 bond requirement to assure removal of this vessel should for some reason it sink in place. In lieu of a large bond, the applicants provided an insurance policy in the amount of \$1,400,000, that in addition to liability coverage, had a specific clause for removal of wreckage.

CURRENT SITUATION:

With the removal of wreckage assured by the insurance policy, staff agreed that a large bond was not necessary. Therefore, the amount of bond required by the lease was reduced to \$5,000 which is sufficient to assure performance of the lease terms and conditions. It is therefore recommended that the authorization approved September 4, 1984, Minute Item No. 1, be amended.
