Initial period: Five years beginning
January 1, 1980.

Surety bond: \$1,000.

Public liability insurance: Combined single
limit coverage of \$100,000.

Consideration: \$4,453 per annum; five-year
rent review.

TERMS OF FIRST RENEWAL:

Initial period: One year beginning January 1,
1985.

Surety bond: \$5,000.

Public liability insurance: Combined single
limit coverage of \$500,000.

determined that this activity is exempt
from the requirements of the CEQA as a
categorical exempt project. The project is

2. AUTHORIZE ISSUANCE TO FRED PFYFFER OF A FIVE-YEAR GRAZING LEASE BEGINNING JANUARY 1, 1986; IN CONSIDERATION OF ANNUAL RENT IN THE AMOUNT OF \$4,453, PROVISION OF A \$5,000 SURETY BOND; PROVISION OF PUBLIC LIABILITY INSURANCE FOR COMBINED SINGLE LIMIT COVERAGE OF \$500,000; FOR LIVESTOCK GRAZING ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.


