ACCEPTANCE OF LEASE QUITCLAIM DEED  
FOR STATE OIL AND GAS LEASE PRC 987, ORANGE COUNTY

LESSEE: Ocean Front Oil Co.

SUMMARY: At its January 31, 1985 meeting, the Commission approved a Memorandum of Agreement with the State Lessee, Ocean Front Oil Co. providing that in exchange for completion of abandonment of well "State PRC 987 Davis-11" and execution and delivery of a Lease Quitclaim to State oil and gas Lease PRC 987, in favor of the Commission, a refund would be made to Ocean Front of \$21,300 of disputed royalties paid under protest to the Commission.

All terms of this Memorandum of Agreement have been satisfied.

PREREQUISITE ITEMS:

1. The plug back/abandonment operations at well "State PRC 987 Davis 11" have been monitored and completed consistent with the rules and regulations of the State Lands Commission and the California Division of Oil and Gas.
2. Lease Quitclaim Deed has been duly executed by the lessee and reviewed for legal sufficiency by Staff Counsel.

3. All rental and royalty payments are current and no liability appears to exist on this lease.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because it is not a "project" as defined by CEQA and the State CEQA Guidelines.
