ANNEXATION OF SUBMERGED LANDS,  
CITY OF REDDING, SHASTA COUNTY

The State Lands Commission has received a request from City of Redding to review and approve the annexation and boundaries of the proposed Sacramento River Trail Annexation (No. 85-10).

This area includes approximately 756.30 acres, more or less, of land including a portion of the present and historic submerged lands in the bed of the Sacramento River. The area proposed for annexation is located westerly of previously annexed areas and involves an approximate one-mile stretch of the Sacramento River in Section 28, T32N R5W, MDM.

Pursuant to Government Code Section 56108(c) and (d), the Commission is to review and approve or deny the proposed annexation boundaries as appropriate and correct within 45 days.

The staff of the Commission has reviewed the proposed annexation boundary description and finds it adequate. Furthermore, staff has no objection to transfer of local police power jurisdiction from the county to the city pursuant to 56108(a) and, therefore, submits the recommendations of approval below.

3. CONSENT, AS THE LANDOWNER, TO THE PROPOSED ANNEXATION OF SUBMERGED LANDS UNDER THE OWNERSHIP AND JURISDICTION OF THE STATE LANDS COMMISSION IN THE BED OF THE SACRAMENTO RIVER WITHIN THE AREA DESCRIBED IN EXHIBIT "A" PURSUANT TO GOVERNMENT CODE SECTION 56108(a).
4. AUTHORIZE STAFF COUNSEL TO GIVE THE REQUISITE NOTICE OF SAID APPROVALS TO THE CITY OF REDDING AND TO THE EXECUTIVE OFFICER OF SHASTA COUNTY LAFCO PURSUANT TO CALIFORNIA GOVERNMENT CODE SECTION 56108(e).

LEGAL DESCRIPTION




