APPROVAL OF AMENDMENT ON RECIPROCAL
ROAD USE AGREEMENT PRC 6882

APPLICANT: GEO Operator Corporation
1330 North Dutton Avenue, Suite A
Santa Rosa, California 95401

AREA, TYPE LAND AND LOCATION:
New road construction alignment change at the
Geysers in Lake County which will shorten the
overall construction by 0.87 miles, and involve
0.71 miles on school lands.

LAND USE: Reciprocal road right-of-way use.

TERMS OF ORIGINAL AGREEMENT:

Initial period: 49 years beginning
September 1, 1985.

Special: The Commission authorized
this Agreement at its meeting
of August 29, 1985

TERMS OF AMENDED AGREEMENT:

Initial period: 49 years beginning
September 1, 1985.

Special: The effective date of this
amendment is April 1, 1986

BASIS FOR CONSIDERATION:

Pursuant to 2 Cal. Adm. Code 2003.

APPLICANT STATUS:

Applicant is lessee of adjacent geothermal
projects.

OTHER PERTINENT INFORMATION:

1. GEO Operator Corporation proposed a road alignment change which will shorten the Coldwater Creek portion of new construction by 0.87 miles. The realignment will include a route involving 1.78 miles of new construction which will cross 0.71 mile of school lands described as the SE1/4 SE1/4, Section 24, T12N R9W, MDB&M. The realignment will also eliminate a route involving 2.65 miles of new construction, including 0.28 mile through school lands described as Lot 7, Section 19, T12N R8W, MDB&M. Construction for this project in the Geysers area in Lake County is scheduled to begin April 1986.
2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15025), the staff has prepared a Proposed Negative Declaration identified as EIR ND 386, State Clearinghouse No. 85052110. Such Proposed Negative Declaration was prepared and circulated for public review pursuant to the provisions of CEQA and was certified by the Commission at its August 29, 1985 meeting (Minute Item No. 10).

When the road was realigned, a new initial study was prepared and circulated. Based upon the information received from such circulation, the new alignment has less effect on the environment than the original. Therefore, it is staff's belief that the previously prepared Negative Declaration remains applicable to the activity at hand.




