FIFTH MODIFICATION OF THE 1986-87  
PLAN OF DEVELOPMENT, OPERATIONS AND BUDGET,  
LONG BEACH UNIT, WILMINGTON OIL FIELD,  
LOS ANGELES COUNTY

The City of Long Beach has requested approval of the Fifth Modification of the 1986-87 Plan of Development, Operations and Budget, Long Beach Unit. This modification would modify the Plan to provide for the replacement of piping at the J-2 site. The total adjusted budget would remain unchanged at \$137,135,000.

Part of the piping at the Pier J water treating facility is showing signs of severe internal corrosion. This uncoated piping was installed in 1970. It has been proposed that it be replaced with internally coated pipe at an estimated cost of \$178,000 before there is a major failure. This project was not included in the current Plan. There are surplus expense funds in the Water Injection Program so augmentation is not required.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the State CEQA Guidelines.

Authority: P.R.C. 21056 and 14 Cal. Adm. Code 15378.
