AUTHORIZATION TO FILE DISCLAIMER RE:
UNITED STATES OF AMERICA U. 141.96 ACRES OF LAND,
MORE OR LESS, ET AL., UNITED STATES DISTRICT COURT,
EASTERN DISTRICT OF CALIFORNIA, CIVIL NO. F-86-484-REC,
TUOLUMNE COUNTY

The State Lands Commission is a party to a condemnation action brought by the United States Attorney entitled United States of America u. 141.96 Acres of Land, More or Less, etc., et al., filed in the United States District Court, Eastern District of California, Civil No. F-86-484-REC involving land in Tuolumne County to be used in connection with New Melones Lake.

Upon examination of the Commission's records pertinent to the area, it has been ascertained that there is no interest held by the State Lands Commission (Commission) as to the tract of land described in the notice of condemnation.

Inasmuch as this suit involves land over which the Commission has no jurisdiction, it is recommended that a disclaimer be filed on behalf of the Commission disclaiming any right, title, or interest in the tract of land which is the subject of this condemnation.

1. FIND THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. ADM. CODE 15061 BECAUSE THE ACTIVITY IS NOT A PROJECT AS DEFINED BY P.R.C. 21065 AND 14 CAL. ADM. CODE 15378.


