APPROVE THE EXECUTION AND RECORDATION OF  
MEMORANDUM OF AGREEMENT

PARTIES: Signal Bolsa Corporation  
Signal Landmark, Inc.  
Signal Landmark Properties, Inc.  
California Department of Fish and Game  
California State Lands Commission

The State and Signal are parties to the 1973 Boundary Settlement and Exchange Agreement (BLA 137) regarding lands in the Bolsa Chica Area, Orange County, dated January 25, 1973.

The lease and option period in the original 1973 Agreement has been extended twice. The most recent extension will expire April 17, 1987.

The State, Orange County, Signal and other interested parties have been involved in the preparation and approval of a local Coastal Program for the subject area as well as encouraging the completion of the United States Army Corps of Engineers Sunset Harbor Study. While these processes are still continuing - progress has been made. At its meeting on February 17, 1987, the Commission authorized the execution of a reimbursement agreement with Signal Landmark, Inc. to provide funding to the Commission for costs incurred as the local sponsor of a "Work for Others Program". The Program will be conducted by the United States Army Corps of Engineers Waterways Experiment Station to study physical and environmental affects of a proposed ocean entrance system at Bolsa Chica.

In order to provide additional time in which to complete these processes and obtain an appropriation to complete an ocean entrance channel, an extension of the option period is essential. Therefore, the parties wish to further extend the option period in which to obtain an appropriation to August 17, 1988 and also extend the construction completion date to August 17, 1991.

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. THE TERMS OF THE OPTION TO ACQUIRE AS DESCRIBED IN PARAGRAPH 3(a) OF THE LEASE SHALL BE EXTENDED FOR AN ADDITIONAL YEAR AND FOUR MONTHS FROM APRIL 17, 1987 TO AUGUST 17, 1988, TO PROVIDE FOR ADDITIONAL TIME TO OBTAIN THE "APPROPRIATION", AND FROM AUGUST 17, 1987 TO AUGUST 17, 1991 TO COMPLETE CONSTRUCTION OF A NAVIGABLE OCEAN ENTRANCE.



MEMORANDUM OF AGREEMENT

THIS AGREEMENT is entered into as of the \_\_\_\_\_ day of April, 1987 by and among the State of California, acting by and through the California State Lands Commission, as Lessee and Optionee ("SLC"), the State of California, acting by and through the California Department of Fish and Game, as Sublessee ("DFG"), Signal Bolsa Corporation, a California Corporation, and Signal Landmark, Inc., a California Corporation, as Lessor and Optionor (hereinafter collectively referred to as "Signal").

RECITALS

A. Signal and the State of California, acting by and through SLC, entered into a Lease of Right of User and Option to Acquire Real Property, dated January 25, 1973 ("Lease/Option"), the date of recordation and effective date of which was August 17, 1973. The term of the "Lease" is for a period of fourteen (14) years commencing on said effective date.

B. Paragraph 3 of the Lease/Option grants to SLC the exclusive right and option to acquire ("Option") all of Signal's right, title and interest in and to the lands subject to the Lease/Option upon the satisfaction of certain conditions. One

such condition requires SLC to obtain within ten (10) years from the effective date of the Lease/Option, an "Appropriation" as that term is defined in Section 1.1 of the Boundary Settlement and Land Exchange Agreement Regarding Lands in the Bolsa Chica Area, Orange County, California, dated January 25, 1973 ("Settlement Agreement"). Under the terms of the Lease/Option, the Option was to have expired on August 17, 1983.

C. Pursuant to Commission action of May 31, 1983, Minute Item No. 26, the parties hereto on August 15, 1983, entered into and recorded on August 14, 1983, in the Official Records of Orange County, as No. 83-355937, a Memorandum of Agreement, (the "1983 Memorandum of Agreement"), as evidence and notice of the agreement to amend the Lease/Option by extending until August 17, 1986 the period in which Lessee may obtain an Appropriation.

D. Pursuant to Commission action of November 20, 1986, Minute Item No. 36, the parties hereto entered into on December 2, 1986 and recorded on January 28, 1987, in the Official Records of Orange County, as No. 87-048842, an Agreement (the "1986 Agreement"), as evidence and notice of the agreement to amend the Option by extending until April 17, 1987 the period in which the State may obtain an Appropriation.

E. Pursuant to Commission action of March 26, 1987, Minute Item No. 32, the SLC has authorized the execution of this agreement.

NOW, THEREFORE, for and in consideration, the receipt and adequacy of which are hereby acknowledged, the parties agree as follows:

1. The Lease/Option, the Settlement Agreement, the 1983 Memorandum of Agreement, and the 1986 Agreement are hereby amended to provide that the time permitted to Lessee to comply with the Option to obtain an Appropriation is extended until August 17, 1988 and the period of the Lease of Right of User (Lease) shall be extended to August 17, 1991. Nothing in this Agreement shall amend any other provision or term set forth in

Agreement shall amend any other provision or term set forth in the Lease/Option, the Settlement Agreement, the 1983 Memorandum of Agreement, or the 1986 Agreement.

IN WITNESS WHEREOF, the undersigned being duly authorized to sign on behalf of their respective agencies, hereby execute this Agreement, effective as of the date first set forth above.
